The meeting of The District Development Committee in respect of Biswanath District was held under the Chairmanship of the Deputy Commissioner, Biswanath on 10/03/2022 at 11.00 am at Gangmou Than organized by PWD (R) Department. The meeting was attended by the CEO, Zilla Parishad of Biswanath, Addl. Deputy Commissioner (Dev.), Asstt. Commissioner, Biswanath and officers of all the Departments in Biswanath District.

After a threadbare discussion, the following department wise resolutions were taken:-

Zilla Parishad	<ul style="list-style-type: none">➤ In the meeting, the CEO Biswanath brought up the issue of the erosion of the Burigang river near Mijika to Tinsuti PWD road under Mijika GP of Baghmara Development Block. Resolution of the meeting about the issue The DC, Biswanath recommended to taken up embankment work with Geo Bag in the sensitive area as soon as possible in convergence with Water Resources Department and under MGNREGA.➤ The BDO Baghmari is informed to identify soil erosion area near Borgang River.
2.	Water Resource	<ul style="list-style-type: none">➤ The Executive Engineer, Water Resource Biswanath was instructed to immediately start new scheme/ works of soil erosion in Behali LAC.➤ He was further instructed that anti erosion measures be taken to protect Bharalijuli & Tangabari area from the erosion of river Borgang. Work must be started at the earliest.
3.	Industries & Commerce	<ul style="list-style-type: none">➤ The Deputy Commissioner, Biswanath informed the Asstt. Director of Industries & Commerce, Biswanath to put up status of 37 Nos. of schemes at the earliest which have already been completed.➤ The Asstt. Director of Industries & Commerce, Biwanath was also directed to convert private land to industrial land for establishing industries in Biswanath District.


4.	Power	<ul style="list-style-type: none"> ➤ Gingia, Burhigang Land Acquisition completed but Sonapur Land Acquisition is not progressed. Hence the AGM, APDCL of Biswanath is directed to speed up the work. ➤ The DC, Biswanath further directed AGM, Biswanath that street light diversion of National Highway work may be done collaboration with NHIDCL and submit work progress in next DDC. ➤ The AGM, Biswanath is instructed to organize a meeting with Hon'ble MLAs of Biswanath, Behali & Gohpur LAC and the DC, Biswanath regarding SAUBHAGYA Scheme and electrification of Bholaguri TE and Berubari.
5.	Employment	<ul style="list-style-type: none"> ➤ The DC, Biswanath directed the Superintendent of ITI to attend the next DDC meeting.
6.	Social Welfare	<ul style="list-style-type: none"> ➤ The DSWO, Biswanath is directed to carry out survey regarding differently-abled people and issuance of Disability Certificate in the district and to submit a detailed report to the Deputy Commissioner, Biswanath by next week. ➤ Construction of One Stop Centre progress is very slow. Therefore, The i/C District social Welfare Officer is instructed to review the matter and submit a status report. ➤ He is also instructed to take action of Disability Certificate in tea garden areas. The survey is to be conducted alongwith all CDPOs and Anganwadi workers. ➤ Screening camp for Disability must be conducted in Biswanath district for greater interest of the people of Biswanath district.
7.	Sericulture	<ul style="list-style-type: none"> ➤ The Superintendent of Sericulture was instructed to discuss with the DC, Biswanath regarding proper implementation of Centrally Sponsored/Centrally Sector Scheme.
8.	Veterinary	<ul style="list-style-type: none"> ➤ The Sub-Divisional Veterinary Officer is directed to convene a meeting with LDM, Biswanath regarding KCC. ➤ The SDVO is further directed to handover seven bighas un-utilized land in Gohpur Sub-Division.

9.	Education	<ul style="list-style-type: none"> ➤ The BEEO, Biswanath is directed to scrutinize the matter of online applications related to mutual transfer of teachers. ➤ He is instructed to attach other contractual/regular teachers in schools having a single teacher. ➤ He is further directed to change teacher in Bodo medium Schools who are from non Bodo Speaking Community.
10	Forest	<ul style="list-style-type: none"> ➤ The DFO, Sonitpur East Division, Biswanath is directed to the provide co-ordinates of 14 villages which are shown by Arunachal Pradesh as their villages.
11	Irrigation	<ul style="list-style-type: none"> ➤ The Executive Engineer, Irrigation, Biswanath is directed to construct deep boring in Gangmou Than, Behali. ➤ The Executive Engineer, Irrigation, Biswanath is directed to ensure that AEE, Irrigation, Behali to attend office regularly and stay as well as work out of the Headquarter. ➤ Solar Powered MDTW Scheme under SOPD for the year 2018-19 in Biswanath, Behali & Gohpur LAC (Sootea, Biswanath, Sakomatha, Baghmara, Behali& Pub Chaiduar) Cumulative progress 48% only. The EE (Irrigation) Biswanath is directed to take necessary action at the earliest.

The EE PWD (TR) of Biswanath is directed to take note of the matter and to upgrade work at the earliest. ➤ Construction of Inspection Bungalow Building RCC at IB campus in Sootea under Untied Fund for 2019-20 Physical Progress 80% only. The EE PWD (TR) of Biswanath is directed to ensure quick progress towards completing the task. ➤ The DC of Biswanath District instructed The EE PWD (TR) of Biswanath for repair the Circuit House road at the earliest.
13	PWD (Building)	<ul style="list-style-type: none"> ➤ Construction of B. Ed College at Village Gerubari under

Office/Secretary RTA at Biswanath Chariali and ensure progress of the work. ➤ He is instructed to call the concerned contractor of Sakomatha Model School immediately and directed him to complete the work at the earliest. ➤ He is further directed to scrutinize and expedite the work progress of the improvement work of Town Hall at Biswanath District.
14	Handloom & Textile	<ul style="list-style-type: none"> ➤ The Superintendent of Handloom & Textile, Biswanath is directed to promote the scheme of Assam Agri- business and provide skill up-gradation training and adequate facility to weavers before Bihu. ➤ He is also directed to meet the DC, Biswanath to discuss about Handloom Cluster Development Programme, at Kalapani under SOPD-G. ➤ The Superintendent of Handloom & Textile, Biswanath was further directed to improve Yarn Bank and provide loom & accessories to weavers. ➤ He was also instructed to form Eri cluster at Bharalijuli and registration of SHGs to be done under ASRLM, Biswanath.
15	Agriculture	<ul style="list-style-type: none"> ➤ The District Agriculture Officer, Biswanath was directed to increase watermelon and coconut production in Biswanath District.
16	NHIDCL	<ul style="list-style-type: none"> ➤ The Manager, NHIDCL is directed to regularly submit progress report of ongoing works of Highway construction to the Office of the Deputy Commissioner, Biswanath.

The Chairman asked all concerned HODs to complete the target and sort out inter departmental issues with relevant solutions and requested the departments to bring the notice of the issues which are yet to be resolved.
