
After a threadbare discussion, the following department wise resolutions were taken:-

| 7. | Fishery | ➤ The Fishery Officer, Biswanath is directed to discuss with Bank Managers regarding, sanction of KCC loan to make Biswanath District self sufficient. |
| 8. | Health | ➤ The Joint Director of Health Services, Biswanath is directed to take action for eradication of anaemia in Biswanath District and to provide treatment during the period of delivery of women and try to reduce MMR (Maternal Mortality Ratio) in Biswanath. |
| 9. | Agriculture | ➤ The District Agriculture Officer, Biswanath is instructed to complete Aadhaar Seeding of PM KISAN before next DDC. |
| 10. | Social Welfare | ➤ The I/C District Social Welfare Officer, Biswanath is directed to issue Disability Certificates to disabled persons as soon as possible. |

The Chairman asked all concerned HODs to complete the target and sort out inter departmental issues with relevant solutions and bring the notice of the issues which are yet to be resolved.


