Agriculture	<ul style="list-style-type: none"> ➤ The District Agriculture Officer, Biswanath is directed to organize a meeting on 13/01/2022 regarding paddy procurement. ➤ The DAO, Biswanath is directed to put effort to achieve the target under the flagship scheme of PMKSY (Micro Irrigation). ➤ The DAO, Biswanath is directed to coordinate with other departments regarding shortage of beneficiaries regarding distribution of sprinklers and power tillers under CMSGUY and to give publicity to increase beneficiaries.

PHE	<ul style="list-style-type: none"> ➤ The Executive Engineer (PHE) is directed to organize a meeting on Retrofitting Schemes under JJM. ➤ The Deputy Commissioner, Biswanath directed the EE (PHE) to arrange joint meeting with P&RD to expedite the progress of JJM under Anganwadi Centres (AWC). The CEO, Zilla Parishad is requested to coordinate with Executive Engineer, PHE to monitor the works under JJM.
3.	PWD (Building)	<ul style="list-style-type: none"> ➤ The Asstt. Executive Engineer, PWD (B), Biswanath Chariali Division is directed to follow up with contractors of the schemes having slow progress and was asked to give a presentation of the works after Bihu.
4.	Irrigation	<ul style="list-style-type: none"> ➤ The Executive Engineer, irrigation is directed to send official letter to contractors to complete all scheme within January. He is further directed to revalidate the schemes undertaken under PMKSY.
5.	Transport	<ul style="list-style-type: none"> ➤ The DTO, Biswanath is directed to achieve the target of revenue collection. He is further directed to increase training on driving and organize an enforcement team on 'Drunk & Drive'.
6.	Education	<ul style="list-style-type: none"> ➤ The Inspector of Schools is directed to collect detailed data of single teacher LP schools. He is directed to ensure that the

		completion certificate of schemes under JJM in schools must be given by SMC of the concerned school.
7.	Health	<ul style="list-style-type: none"> ➤ The Joint Director of Health Services, Biswanath is directed to ensure that the Community Health Officers are engaged in Health & Wellness Centres at the earliest under Biswanath District. ➤ Awareness programme to be conducted on AYUSHMAN BHARAT Scheme.
8.	Sports	<ul style="list-style-type: none"> ➤ The District Sports Officer, Biswanath is directed to inspect ongoing construction work and to report on its progress.
9.	Veterinary	<ul style="list-style-type: none"> ➤ The Hon'ble MLA of Sootea LAC directed Sub-Divisional Veterinary Officer, Biswanath Chariali to conduct awareness programme regarding milk production, subsidiary food production for animals, medical support for animals.
10	Environment & Forest	<ul style="list-style-type: none"> ➤ The DFO, Sonitpur East Division is directed to take steps for plantation in an area of about 48 hectares in Singlijan Reserve Forest. An area of about 78 hectares in Seijosa should be reserved for plantation purpose.
11	Sericulture	<ul style="list-style-type: none"> ➤ The Superintendent of Sericulture, Biswanath Chariali and BDO, Behali are directed to ensure that proper fencing is done in Eri concentration center at Rangali. ➤ Local Lady Weavers are to be engaged in Pub-Chaiduar.
